

The American Medical Association (AMA) has formed a National Advisory Panel entitled, *Transforming the Transition in Medical Education*. The overall goal of the initiative is to improve the medical education transition from UME to GME by positively impacting learner preparedness and resiliency as well as patient outcomes within health care systems using both learner-centered and patient-centered approaches. The AIAMC is well-represented on this esteemed panel, which includes leaders from the ACGME, ABMS, AHA, VA and others (see sidebar). **Jacob Bidwell, MD**, VPAA, **Aurora Health Care**, **Robert Dressler, MD**, Quality and Safety Officer

for Academic and Medical Affairs, **Christiana Care**, and President, AIAMC Board, **Tsveti Markova, MD**, DIO, Wayne State/**Crittenton Hospital** and Director, AIAMC Board and Kimberly Pierce-Boggs, Executive Director, AIAMC, will participate in two in-person meetings in Chicago over the summer months with outcomes and responsibilities to include: Advise and inform AMA leadership on trends and innovations in medical education that are applicable to the UME—GME transition; Provide input and assist in the review process for the Request for Proposals/Applications to support medical schools and GME sponsors with the resources to implement innovative and impactful

change; and Propose strategies to disseminate innovations derived from the projects selected. The AMA is launching this new effort as its *Accelerating Change in Medical Education* initiative is approaching the end of its first five years. This 32-member consortium, with the help of multi-million dollar grants from the AMA, is delivering forward-thinking, innovative educational experiences to approximately 19,000 medical students. The AIAMC congratulates the AMA on their successes to date and thanks them for including us in this next phase of transforming medical education.



National Academies Release GME Outcomes and Metrics

The National Academies of Sciences, Engineering, and Medicine recently released [proceedings](#) of a workshop on Graduate Medical Education Outcomes and Metrics, held in October 2017. The AIAMC was a sponsor of the workshop, along with ACGME, ABMS, AOA, the Josiah Macy Jr. Foundation and others. The [report](#) summarizes the presentations and discussions from the workshop and highlights suggestions from participants regarding meaningful and measurable outcomes of GME, possible metrics that could be used to track these outcomes, and possible mechanisms for collecting, collating, analyzing and reporting this data.

National Initiative VI Reaches Mid-Point

July marks the ninth month of the 18-month AIAMC National Initiative VI: *Stimulating a Culture of Well-Being in the Clinical Learning Environment*. Thirty-four AIAMC member teams are hard at work and eager to improve the well-being of residents, faculty and health systems. Two on-site learning sessions have been held with record attendance, as well as monthly teleconferences and webinars designed to keep teams on track. “Member participation and collaborative networking on the monthly progress report calls have been exceptional”, stated AIAMC Executive Director Kimberly Pierce-Boggs. “And, the three didactic webinars held to date yielded evaluation scores as high as 4.75 on a 5-point Likert scale. Clearly, the teams are engaged and making a difference.” The next on-site learning session will be held October 12th and 13th in Denver and will include a CEO/CAO panel of AIAMC member hospitals that are effectively addressing well-being in the framework of gene code, zip code and work load. Dr. Ankel completed his Emergency Medicine residency training at the University of Illinois.


