## A Message from the President

It has been my distinct honor to serve as your President for the past two years. AIAMC members include leaders from major groups such as the AAMC, ACGME, AHA, and NRMP as well as numerous national efforts and task forces. The individual accomplishments of our members and the continued progress of the Alliance are a continued source of inspiration and motivation, and it's truly been a privilege to lead this organization.

In the first quarter of 2017, we completed National Initiative (NI) V: *Improving Community Health and Health Equity.* The AIAMC Board was quite proud, but not surprised, when the Centers for Medicare and Medicaid Services' (CMS) Office of Minority Health (OMH) reached out and asked to learn more about and help share the results of this impressive work. Eleven case studies highlighting NI V projects will soon be released by the OMH. Mid-year, we launched National Initiative VI: *Stimulating a Culture of Well-Being in the Clinical Learning Environment.* Thirty-four AIAMC member institutions and more than 400 individuals are participating in NI VI, and the AIAMC Board is working with many national organizations in leading well-being efforts across the country. The AIAMC was the only national medical education membership organization selected to serve as an inaugural sponsor of the National Academy of Medicine's (NAM) *Action Collaborative of Clinician Well-Being and Resilience.* 

The AIAMC continues to thrive as a national organization, consisting of a record high of 90 member institutions from every region in the U.S. By the end of 2017, we welcomed the addition of 15 new member institutions to the Alliance. The AIAMC Board is constantly assessing potential members and identifying independent academic medical centers dedicated to seeking collaborative and innovative solutions to important problems that we face not only today, but in the foreseeable future.

I look forward to seeing many of you at the 2018 Annual Meeting at the spectacular Omni La Costa Resort and Spa in Carlsbad, California. Please join us there in welcoming Rob Dressler, MD, as the next President of the AIAMC, and Shelly Monks as our new President-elect. Finally, I wish to thank and recognize my predecessor Dr. Ron Amedee and the entire AIAMC Board of Directors and staff for their support and hard work this past year. I look forward to 2018 with great anticipation.

## 2017 Accomplishments

## National Initiative V Completed



More than 300 participants from 29 AIAMC-member institutions completed National Initiative V: *Improving Community Health and Health Equity* in March 2017. Eleven team leaders were interviewed in the summer of 2017 by

representatives from the Centers for Medicare and Medicaid Services' (CMS) Office of Minority Health (OMH). Projects selected were based upon OMH's identification of promising practices worthy of exploring for more granular learnings to develop case studies and share with CMS constituents.

## **Record Membership Achieved**

Fifteen new hospitals and health systems joined the AIAMC in 2017, bringing our total membership to a record-high of 90. We welcomed the following IAMCs to our membership: Arrowhead Regional Medical Center (CA), Coliseum Medical Centers (GA), Community Health Network (IN), Covenant Children's Hospital (TX), Covenant Medical Center (TX), Grand Strand Medical Center (SC), The Medical Center of Aurora (CO), North Suburban Medical Center (CO), Orange Park Medical Center (FL), Presbyterian/St. Luke's Medical Center (CO), Rose Medical Center (CO), Sky Ridge Medical Center (CO), Swedish Medical Center (CO), Trident Medical Center (SC) and Wesley Medical Center (KS). AIAMC members now sponsor more than 10,000 residents in 745 ACGME-accredited training programs.

## NAM Action Collaborative Sponsored

The AIAMC was the only national medical education membership organization selected to serve as an inaugural sponsor of the National Academy of Medicine's (NAM) *Action Collaborative of Clinician Well-Being and Resilience*. This effort is led by Drs. Victor Dzau, President, National Academy of Medicine; Darrell Kirch, President and CEO, Association of American Medical Colleges; and Thomas Nasca, President and CEO, Accreditation Council for Graduate Medical Education. The collaborative will assess and understand the underlying causes of clinician burnout and suicide, advance solutions that reverse the trends in clinician stress, burnout and suicide and provide rich resources to AIAMC members participating in National Initiative VI.

## National Initiative VI Launched

National Initiative VI: *Stimulating a Culture of Well-Being in the Clinical Learning Environment* officially launched in October 2017 with the first on-site learning session in Chicago. Thirty-four AIAMC member teams were selected to participate with goals including: Identify strengths and weaknesses in elements of their clinical learning environment's well-being plan; understand and prioritize areas for well-being engagement; and engage the C-Suite and GME in review of the clinical learning environment's well-being efforts.
