

## National Initiative X Teams Announced

Twenty-one AIAMC-member institutions representing 31 team projects have been selected to participate in the AIAMC's National Initiative X: Optimizing the Clinical Learning Environment for the Future. These hospitals and health systems span the United States from Washington State to Florida (see sidebar). The AIAMC National Initiative (NI) is the only national and multi-institutional collaborative of its kind in which residents lead multidisciplinary teams in quality improvement projects aligned to their institution's strategic goals. Seventy-two hospitals and health systems and more than 1,650 individuals have participated in the AIAMC National Initiatives since

2007, driving change that has resulted in meaningful and sustainable outcomes improving the quality and safety of patient care. The clinical learning environment is the foundation of graduate medical education, directly shaping the professional development, well-being, and competency of future physicians. The rapidly evolving landscape of modern healthcare, including emerging technologies, workforce shortages, and growing complexity of patient care, demands that physicians are trained in settings that promote adaptability, lifelong



learning, and resilience. Participants will attend four learning sessions as well as bimonthly cohort zoom meetings during the 18-month Initiative. The Committee on the Integration of Academics and Quality (CIAQ) is led by NI X Co--Chairs Theresa Azevedo-Rousso, MPA, Regional Senior Director and DIO at Kaiser Permanente Northern California and Victor Kolade, MD, Clerkship Director, Internal Medicine, at Guthrie Robert Packer Hospital. CIAQ has approved the summer pre-work of teams and is busy planning the first meeting, which will be held at the Omni Chicago Hotel on October 16th and 17th. By investing in the clinical learning environment, GME programs can create sustainable learning environments not only to meet the challenges of healthcare but also to lead its transformation. We congratulate these teams for their commitment and leadership!
