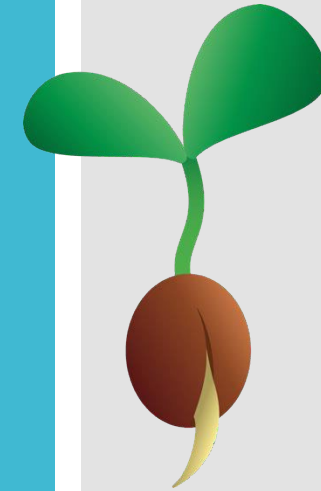


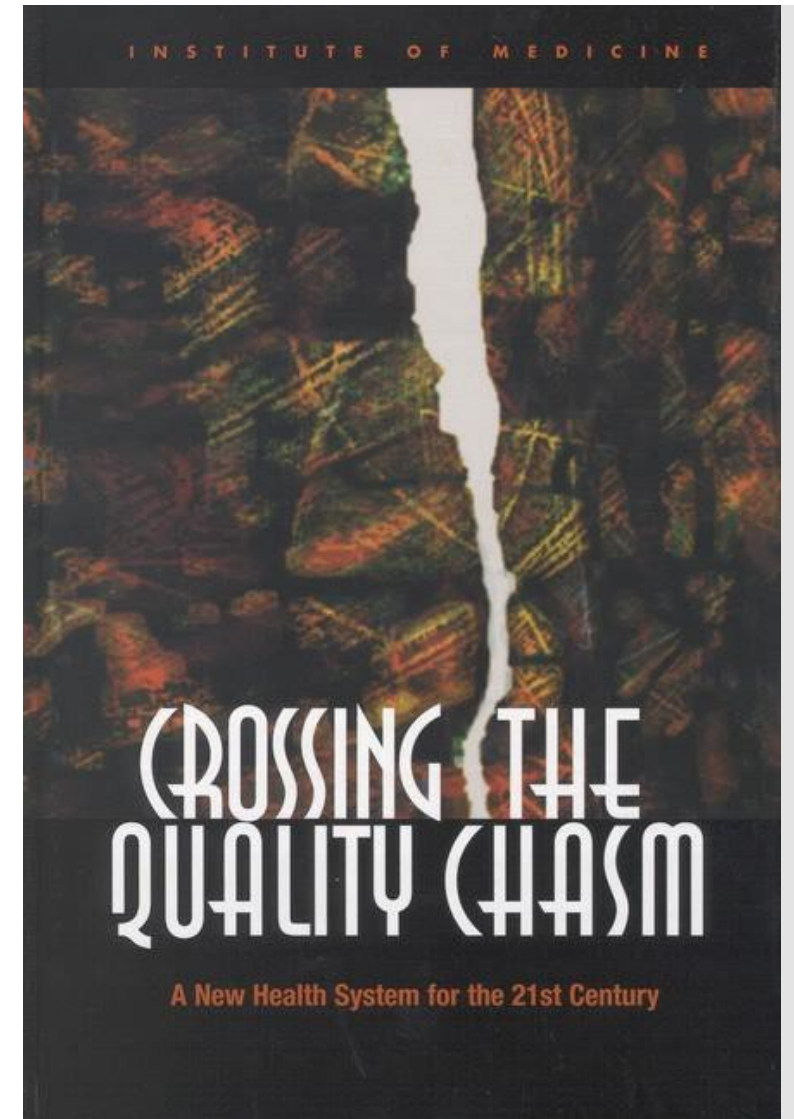

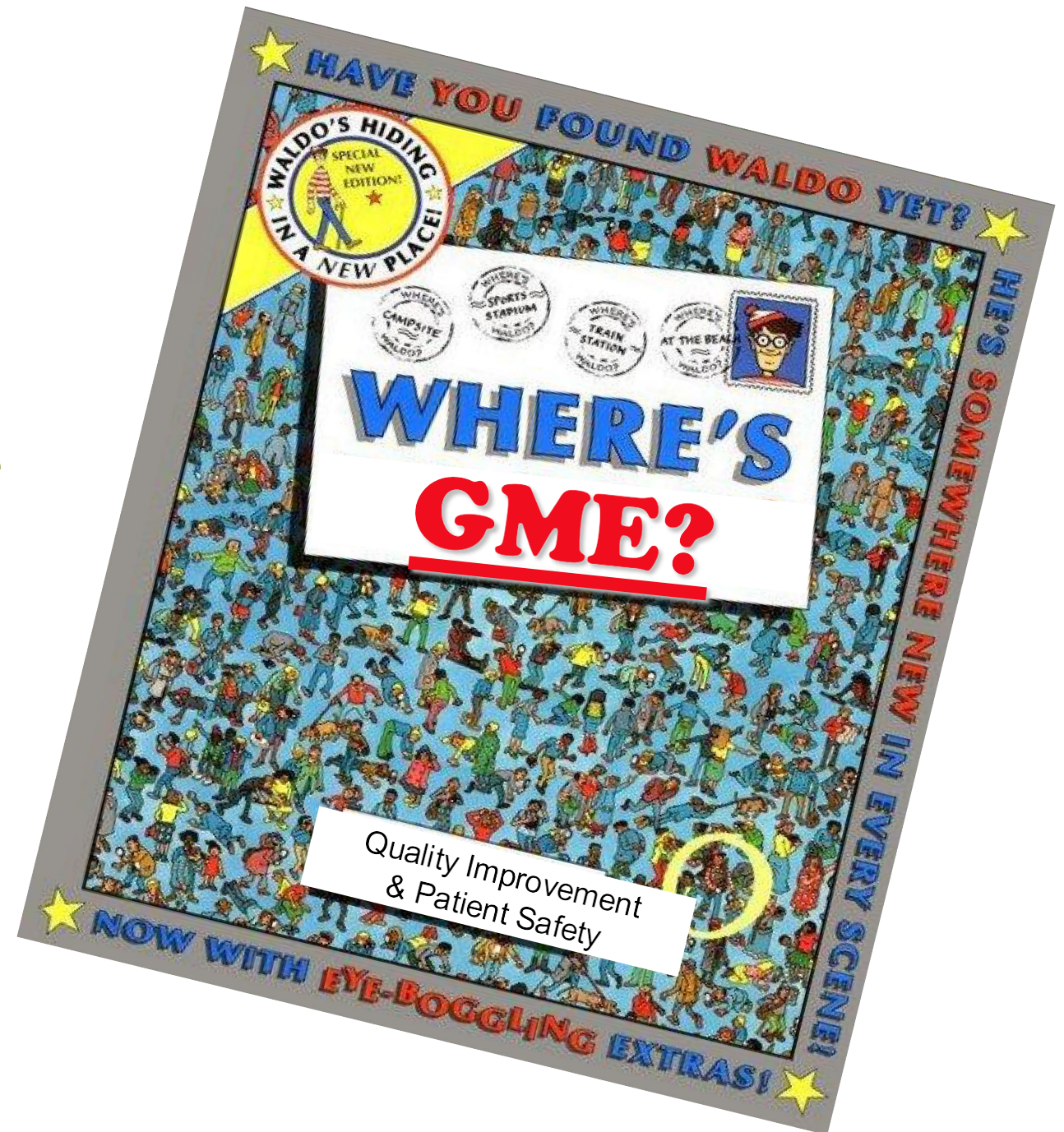
- Crossing the Quality Chasm

Linking Residents and QI

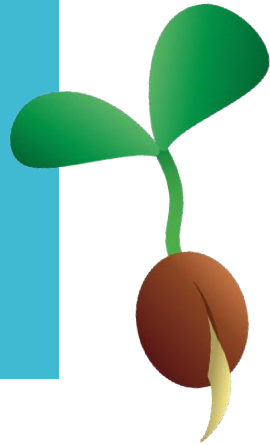

Early Recognition by AIAMC

- In 2006 the AIAMC board approved planning for a national resident QI initiative
- A retreat was held in January 2007 in Phoenix, AZ
- The first National Initiative was launched two months later
- 19 hospital and healthcare systems participated



The Program Framework



- Modelled after Whidbey Island Leadership Retreats
- Four quarterly sessions, groups learning together over time

- A ready template for the National Initiative

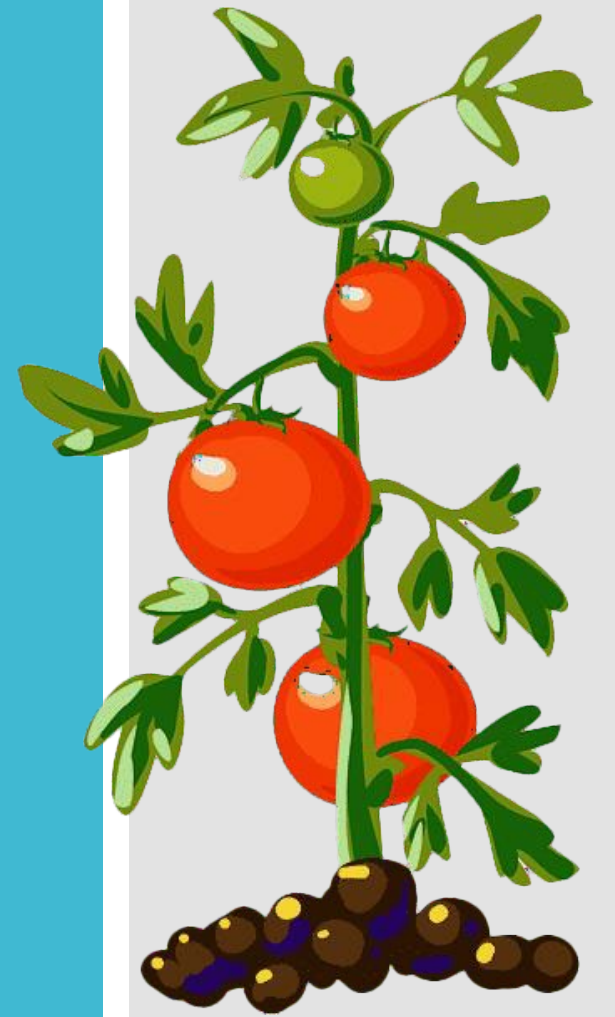
Extraordinary Accomplishments
