30th Anniversary Celebrated



The AIAMC turned 30 years old in 2019 and celebrated this milestone at our annual awards dinner held March 29th at the Loews Ventana Canyon Resort in Tucson, Arizona. Founder and first president Ethel Weinberg, MD, reflected on the early years with the twelve founding members and a handful of passionate medical education leaders. In 2018, the AIAMC unveiled a complete re-brand, including a new

mission, vision, logo and website. The combination of a fresh, new look and reminder of our history resulted in renewed pride for the organization.

National Initiative VI Completed

More than 400 participants from 34 AIAMC-member institutions completed National Initiative VI: Stimulating a Culture of Well-Being in the Clinical Learning Environment in March 2019. Projects focused on institutional well-being, culture and values, workload and job demands, meaning in work, work-life integration and social support.

New Members Welcomed

Four new hospitals and health systems joined the AIAMC in 2019, bringing our total membership to 83. We welcomed the following IAMCs to our membership: Amita Health (Chicago, IL), Baptist Health South Florida (Miami, FL), St. Vincent Evansville (Evansville, IN) and University Medical Center New Orleans (New Orleans, LA). - Identify local strengths and opportunities for Teaming at the Micro, Meso and Macro environment levels
- Prioritize areas for IPCP Teaming
- Engage the C-Suite and Leaders of Health Professions Education in review of Teaming in the clinical learning environment
- Develop, implement, and evaluate a Teaming project
- Significantly and measurably advance the clinical learning environment's efforts in Teaming, disseminating results within your organization's Micro, Meso and Macro environments
- Participate in a collaborative national effort to identify and share best practices
- Author one or more peer reviewed scholarly products at the conclusion of the Initiative
